<u>Gate Transmitters</u>: Gate clickers can be purchased for \$40 at the District Office from the General Manager, Angela Johnson 677-5889. Please call for appointment.

<u>Gate Transmitter Battery Replacement</u>: Gate clicker battery replacement: Duracell security 21/23(12v NM21/A23) or another brand equivalent.

<u>Decals</u>: You can obtain the free CECSD vehicle decals (vellow with black oak tree) from the District office.

**Burn Piles:** A permit is required for residential burn piles. Burning is only allowed on "permissive burn days". Permits can be obtained at Station 89 in Cameron Park. Please call 621-5897 before you burn to see if it is a burn day.
