Minutes September 21, 2023 CECSD Board Meeting

Director Panges spoke about several road work concerns in the District. Director Panages discussed the need for rip rap for two ditches on Strolling Hills and one culvert before the Upper Flying C gate that would be placed to contain erosion and preserve the roads. Director Panages identified sections of Lariat Drive that need shoulder backing to keep sections of asphalt from breaking off. The Road Committee and General Manager located deep cracks on Lariat Drive near the Loop and cracks on Cameron Road near Flying C Road. Since the company that crackfills roads also marks the streets, the Road Committee and General Manager identified several locations that needed paint at stop signs and over speed bumps. The Road Committee would also like to cut out and repair Ridgepass near Strolling Hills since the potholes are large and the road is failing. Director Johnson said that the Road Committee identified potholes and marked them for the handyman to fill.

Director Johnson motioned to authorize the General Manager to contract with a construction company up to \$40,000 for repair of the three ditches. Director Reese seconded. All Directors voted aye.

Director Johnson motioned to authorize the General Manager to contract with a construction company up to \$40,000 for crackfilling three roads and pavement marking. Director Reese seconded. All Directors voted aye.

Director Johnson motioned to authorize the General Manager up to \$30,000 for a construction company to do shoulder backing on Lariat Drive and asphalt dig out and replace on Ridgepass. Director Thomson seconded. All Directors voted aye.
